

13		Make improvements based on recommendations made by the stormwater inspector during the annual NPDES inspection.	5					
14		Be compliant with any and all stormwater permits.	5					
15		Dumpster lids are kept closed except when in use. Routinely clean dumpster area, preferably using dry cleaning methods. If power washing, facility/business collects the wash water and disposes of it properly, not allowing it to enter the storm drains.	5					
16		Outdoor areas are kept neat and organized. Tracking of sediment, product materials, etc. off-site is prevented. Regularly clean/sweep litter from the outdoor area of the facility, including cigarette butts. Provide adequate ashtrays to prevent cigarette litter.	5
